DECLARATION

1. I, the undersigned, certify that I am authorised to make this application on behalf of the organisation named in the application ("the Customer" if and when the application is approved).
2. I, the undersigned, certify that to the best of my knowledge, all particulars provided in this application are true and correct.
3. Under the terms of the Privacy Act 1993, I authorise any person or company to provide Freedom Mobility Ltd and/or its representatives with such information as Freedom Mobility Ltd may require in response to this application. Furthermore, I authorise Freedom Mobility Ltd to collect, use and retain any information which may be needed to assess the creditworthiness of our organisation. In the event that payment is not made on time, we acknowledge Freedom Mobility Ltd's right to charge default interest at the rate of 2% per month or part thereof on any amount outstanding, and we undertake to pay Freedom Mobility Ltd all costs and expenses which may be incurred in recovering any overdue amounts.
 - c. Freedom Mobility Ltd may at its discretion, allocate any payment received from the Customer towards any invoice that Freedom Mobility Ltd determines and may do so at the time of receipt or any time after, and on default by the Customer may reallocate any payments previously received from the Customer.
 - d. Freedom Mobility Ltd has the right to suspend or cancel this account without liability and without any prejudice to any other right it has in law, if we the Customer fail to pay any money owing after the due date, or we the Customer commit any act of bankruptcy as defined in Section 19 of the Insolvency Act 1967, or if in Freedom Mobility Ltd's sole view we the Customer may be in a position where we are unable to pay for the service provided when that payment is due.
 - e. Failure to enforce any of the provisions of these terms and conditions shall not be deemed to be a waiver of any rights or obligations Freedom Mobility Ltd may have under this agreement.
 - f. We the Customer shall not assign any or all of our rights under this agreement without the written consent of Freedom Mobility Ltd.
